#### Information Regarding Data Protection When Visiting Our Twitter Page Pursuant to Art. 13, 14 GDPR

We are the managers of the ETO GRUPPE Twitter account on the short message service Twitter. Below, we are informing you about the processing of your personal data by Twitter and by us, ETO GRUPPE TECHNOLOGIES GmbH if you follow our Twitter account and about your rights with regard to data protection. ### I. Processing of Personal Data by ETO GRUPPE

ETO GRUPPE does not personally record and store data when you use Twitter. The data provided and published voluntarily and at your own responsibility on Twitter, in particular your username and the content published under your account, are only processed by us to the extent that your Tweets may be re-tweeted, they may be replied to or Tweets may refer to your account. In this way, the data are integrated in our range of products and services and made accessible to our followers.

### II. Processing of Personal Data by the Operator of the Social Network

Twitter processes the data provided voluntarily by you such as your name and username, e-mail address, telephone number or contacts in your address book when you upload or synchronize it. Twitter also assesses the content shared by you according to which subjects interest you, it stores and processes confidential messages sent to you directly to other users and is able to determine your location using GPS data, information on wireless networks or via your IP address in order to send you advertising or other material.

As operators of the Twitter account, we are neither able to identify in which countries within or outside the EU, to what extent and for how long your data are stored by Twitter, nor whether and to what extent Twitter complies with any erasure duties in force or which assessments and associations are made using the data and to whom the data are forwarded. In particular, we are unable to identify whether and to what extent Twitter, regardless of whether you as the user of the social network are registered or not, uses webtracking tools and uses your profile and behavior data in order to assess your habits, personal relationships or preferences, for example, or to what extent interactions with our Twitter account are allocated to individual users.

Neither are we informed if and to what extent Twitter uses personal data processed when you follow our channel for its own purposes or if these are passed on to third parties.

However, Twitter is responsible for ensuring the security of the data processing.

#### III. Your Data Subject Rights

Where data are recorded for safeguarding our legitimate interests on the basis of Art. 6 Sect. 1 Clause 1 lit. f GDPR, you have the right to lodge a complaint against the processing at any time on grounds arising from the particular situation.

Pursuant to Art. 15 GDPR, you have the right to access the personal information stored about you as well as the right to rectification of wrong data or to erasure where one of the grounds specified in Art. 17 GDPR is given, e.g. where the data are no longer required for the purpose being pursued. Moreover, you have the right to restriction of processing if one of the prerequisites specified under Art. 18 GDPR exists and in cases of Art. 20 GDPR, the right to data portability. Moreover, pursuant to Art. 22 GDPR, you have the right not to be subject to a decision based exclusively on automated processing including profiling which has a legal effect on you or otherwise significantly impairs you.

If you believe that the processing of the respective data violates the applicable data protection regulations, you have the right pursuant to Art. 77 GDPR to lodge a complaint with a supervisory body. The right lodge a complaint can in particular be exercised in the member state in which you reside or the site of the alleged violation.

#### IV. Contact Details of the Controller and the Data Protection Officer

We process data as shown under I. Twitter records and processes data as described under II. You can assert your rights specified under III. at any time against us or Twitter provided that the data processing falls under the scope of application of the GDPR.
